RUD is under no obligation to award a contract to any Bidder as a result of this RFQ.</p> <p>RUD reserves the right to cancel the tendering process at any stage without liabilities</p>
<b>Deadline of Submission of Quotation</b>	February 20, 2023, 12:00
<b>Method of Submission</b>	<p>Quotations must be submitted through e-tendering through <a href="http://www.tenders.ge">www.tenders.ge</a></p> <p><b>Attention: Physical delivery of quotations will NOT be accepted.</b></p> <p>Format: <b>Annex 1: Quotation Submission Form</b> – PDF <b>Annex 3: BOQ</b> – Excel <b>Company Profile (Extract from the Public Registry)</b> – PDF</p>
<b>Currency of Quotation, taxes</b>	<p>Quotations should be quoted in Georgian Lari (GEL)</p> <p>All prices must be exclusive VAT</p>
<b>Only one Bid</b>	<p>The Bidder shall submit only one Bid.</p> <p>Bids submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following:</p> <p>They have at least one managing partner, director or shareholder in common;</p> <p>They have a relation with each other, directly through common third parties, that puts them in a position to have access to information about, or influence on the Bid of, another Bidder regarding this RFQ process;</p>
<b>Language of quotation</b>	English and/or Georgian

<b>Quotation validity period</b>	Quotations shall remain valid for 90 days from the deadline for the Submission of Quotation
<b>Price variation</b>	No price variation due to escalation, inflation, fluctuation in exchange rate, or any other market factors shall be acceptable at any time during the validity of the quotation after the quotation has been received.
<b>Payment Terms</b>	Post payment. The payment will be performed after receipt of goods/services, works and/or services and submission of payment documentation (subject of negotiation)
